INTRODUCTION

The Federación Española de Empresas de Tecnología Sanitaria (FENIN), Spanish MedTech's branch, approved on December 20, 2016 its New Code of Ethical Business Practice, in order to guarantee a stable collaboration framework between HCP HealthCare Professionals, HCO HealthCare Organizations, patient associations, and industry.

The Code of Ethical Business Practice - FENIN includes all the modifications approved by MedTech Europe, applied in Spain since January 2018 with two innovations that deserve to be highlighted:

- Establish the exclusive use of indirect sponsorship in third-party organised educational events so that it is not the companies that decide what Health Care Professionals will benefit from medical training at such events.
- Ensure the transparency of all financial contributions made by companies to support medical training at third-party organised educational events.

By this way, Member Companies shall implement an independent decision-making/review process to identify, prevent and mitigate against potential bribery and corruption risks arising in connection with the provision of a Grant or a Charitable Donation to a specific prospective recipient

When a Receiver requests a Grant, a mandatory Disclaimer text (individual for each company by his Legal Department) must be approved.

The request is received by the Sponsoring Company that (if applicable) accepts it by assigning a maximum economic amount (visible to the Agency) for such Grant.



PGB GENERATES A PDF THAT INCLUDES:

- Name and surname, position and institution of the Health Care Professional (Head of Service / Department) who has made the request including date and time it has been sent.
- Disclaimer text accepted by it.
- Name and surname, position of the person in charge of the Sponsoring Company that has accepted the request including date and time in which it has been accepted.
- Details of the event, type of Grant (specialist, resident, others: nurses etc. Registration, Travel, Accommodation) and amount assigned.
- Details of the Agency that is in charge of the management of the Educational Grant to the Health Care Professional, who has been appointed by the Head of Service / Department of the Health Institution without knowledge of the Sponsoring Company.
- Possibility of segmented export: ZIP folders can be exported with all PDF documents.

Integration - Events Validation System - Code of Ethics of the Health Technology Sector

PGB has API integration enabled with the FENIN Event Validation System, a functionality that had been requested by all Companies since the beginning of the application of the Code.

Through this integration, the Sponsoring Companies, at the time of evaluating the Request to accept or reject, will be able to check if the event - with its visible traffic light - is approved by FENIN without having to visit the website of FENIN Code of Ethics to verify its state.

This new functionality will greatly facilitate the task of acceptance by the Sponsoring Companies by reducing time and work flows for all, thus maintaining PGB's commitment to the guidelines set forth in the FENIN and MedTech Code of Ethics.
